DJJ's key principles for preventing and reducing juvenile delinquency are:

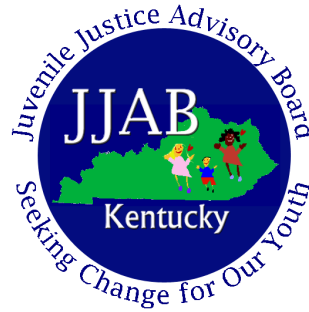
- Strengthening families

- Intervening immediately and effectively when delinquent behavior occurs

JJAB was created in 1997 and is Kentucky's advisory group on juvenile justice issues such as reforming Kentucky's juvenile justice system and creating an effective, equitable system to prevent juvenile crime and delinquency.

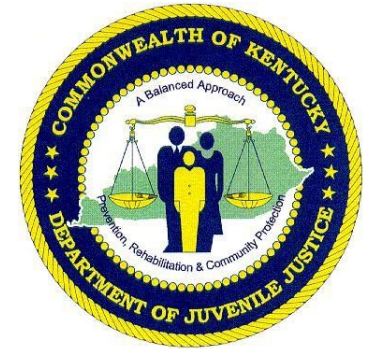
MISSION

DJJ Mission Statement

The Kentucky Department of Juvenile Justice provides comprehensive services to sentenced, committed, probated, and detained youth and their families, creating opportunities for those youth to develop into productive, responsible citizens while enhancing public safety.



WHAT DOES THAT MEAN?

Our staff receives training related to the special needs of juveniles. Facility programming is designed to model positive behaviors and essential life-skills.

Treatment Options

Youth probated or committed to the Department are provided a variety of treatment resources and referrals according to their individual needs.



Possible options include:

- Educational/Vocational programming
- Employment and life-skills training
- Individual, group, and family counseling
- Mental Health Services
- Substance Abuse counseling
- Sex Offender treatment

DJJ Supervision



Youth who are probated or committed to DJJ and placed in the community shall be visited and supervised by DJJ Staff. This may include:

- Home visits
- School contacts
- Treatment Provider Contacts
- Office visits
- Random drug screening
- Curfew checks

When intensive treatment is necessary, youth may be committed to the Department. Committed youth are not always removed from the home.

Probation and commitment timeframes are established by state law and are dependent upon the type and level of offense.
